The initial Ph.D. project Target Agreement, amended by the Target Amendment I subsequent to Module Block II, signed between the Ph.D. student and all his/her supervisors, can be modified as necessary with the help of this Target Amendment. For a Ph.D. project extended beyond the regular study period of three years, a Target Amendment II, corresponding to the 4th year of Ph.D. study, has to be submitted to the Ph.D. program coordination. After three years of ongoing research, changes to the original plans and targets usually have occurred. For this reason, this Target Amendment II serves to establish again a formal agreement between the Ph.D. candidate and all involved supervisors regarding the continued conduct of the Ph.D. research project. The Target Amendment II should adequately outline the project plan until the finalization. If, for unforeseen reasons, the Ph.D. project needs to be extended beyond the candidate's 4th year of studies, another Target Amendment must be submitted by the end of research period III.

This amendment is divided into a chronological record of the research project to date, followed by a chronological listing of feasible targets for the upcoming period, a statement of the expected outcome of the study, and statements of anticipated activities during the next research period (RP III and IV). Please remember that all candidates are expected to submit their results for publication during their Ph.D. studies.
