



How to apply for CIH^{LMU} One Health Network Funds 2021/2022 - Webinar Series-

Background

Through the CIH^{LMU} One Health Network Funds - Call for proposals, the CIH^{LMU} aims to strengthen its partners and alumni and stimulate their collaboration for One Health related research and activities. Therefore, project proposals must emphasize inter-/multidisciplinary One Health aspects crossing faculty boundaries, as well as enhance the connection between applicants with other partner institutions and alumni.

Based on the experience of the CIH^{LMU} Network Fund projects and the more recent CIH^{LMU} One Health Funds 2020, some challenges regarding the proposal writing have been identified. These challenges could be addressed to encourage the submission of eligible proposals. These difficulties can be summarized as follows:

- Lack of knowledge about the CIH^{LMU} One Health approach, resulting in proposals covering problems from only one specific field or discipline.
- Partners do not recognize their leading role in the initiative, resulting in lack of South-South collaboration and a passive role in the development of new projects.
- Lack of knowledge on the administrative aspects to be considered when planning a CIH^{LMU} One Health Funds project. E.g., Confusion in the distribution and use of the
- Non-compliance with formal aspects of the proposal (format, language, number of pages, etc.).
